



# Regional cooperation about Health Workforce:

# The Partnership Project for Global Health and Universal Health Coverage Project (GLO+UHC)

#### Overall Goal (Phase 2):

Partnerships between Thailand and Japan on UHC and global health are strengthened and used to support other countries. Project Purpose (Phase 2):

Capacity on UHC implementation in particular health financing and health workforce and global health of Thailand and other countries are strengthened.

**Country:** Thailand and Participating Countries

Implementing Organization: Ministry of Public Health, National Health Security Office

Term of Cooperation: Phase1: July 14, 2016 to July 13, 2020, Phase2: Dec 11, 2020 to Dec 10, 2023

Output 1. Experiences on UHC are learnt and shared between Thailand and Japan to contribute to improving the UHC in both countries.

Output 2. Capacity development for UHC implementation and global health in other countries is organized.

Output 3. Practical practices and lessons learnt in UHC implementation and global health (mainly from Japan and Thailand) are shared and promoted at national, regional and global levels.

Online Workshop Series on CPD for Nurses (Mar 2022-Feb 2023)

#### Background of in-service training for nurses

- Nurses are the major health professionals and frontline workers in many places.
- The quality of nurses is directly linked to the quality of health care.
- The evidence of best practice is always updated.
- Fragmentated training remains to be a challenge until now.

(China joined the 2<sup>nd</sup> workshop)

Cambodia, Lao PDR, Myanmar, Bangladesh, Bhutan, Nepal and Sri Lanka were in the process of developing CPD systems.







# Regional cooperation about Health Workforce:

# CPD Forum in Bangkok (6-8 June 2023)

#### **Background**

CPD Forum was situated as an advanced version of the Online Workshop Series on CPD for Nurses (Mar 2022-Feb 2023). It aimed to approach Lao PDR and Vietnam more directly and specifically to support them in tackling the challenges/issues they were facing in order to implement their CPD system.



#### **Objectives**

- 1) Analyze the country's current status of the CPD system
- 2) Identify key challenges/issues of the country's CPD
- 3) Develop a country plan for enhancing the CPD
- 4) Strengthen the network between the stakeholders

#### <u>Participants were identified from the Online Workshop Series</u> <u>and the JICA network</u>

- From Lao PDR, 11 officers: Department of Health Personnel, MOH; Healthcare Professional Council; Nursing and Midwifery Board; Medical Board; Dentistry Board; and Pharmacy Faculty, University of Health Sciences.
- From Vietnam, 3 persons: Administration of Science Technology and Training, MOH; Vietnam Nurses Association; and Nam Dinh University of Nursing.
- From Thailand (host country): Thailand Nursing and Midwifery Council (TNMC); Nursing Division, Ministry of Public Health (MOPH); King Chulalongkorn Memorial Hospital (KCMH), The Thai Red Cross Society; National Health Security Office (NHSO); Asia Pacific Action Alliance on Human Resources for Health (AAAH); JICA Thailand Office; and GLO+UHC Phase 2.





#### **Contents**

The following three themes were set according to the challenges/issues of Lao PDR and Vietnam that were revealed in the Online Workshop Series;

- 1. Governance and Regulation
- 2. Standards (Providers/Activities)
- 3. Accreditation process and CPD credit management

TNMC and MOPH provided lectures including the concept, the points to be considered, the lessons learnt from the Thai experience, etc. After the lectures, each country actively discussed the challenges/issues of implementing their CPD system and solutions/measures, facilitated by Thai experts.


